Explanation of Responses:

Each of, Aquilo, the Fund and Mr. Schneidman disclaims beneficial ownership of such securities except to the extent of his or its pecuniary interest therein.

2. Aquilo Capital, LP owns only 3,378,881 of the 4,973,048 shares deemed to be beneficially owned by Aquilo Capital Management, LLC. Aquilo Capital, LP did not purchase any of the 8,867 shares purchased in this transaction on 01/10/2022.
